Being fully aware of the regulations, tariffs and other provisions currently in force, **I DECLARE:**

1. To use the track under the conditions listed, already duly accepted.
2. To indemnify in the broadest way, for myself and my heirs, **ASD THEITALIANSUPERBATTLE and AMUB SPA**, owner and manager of the Circuit, from any compensation for damages for any injury or damage — whatever its duration, outcome and consequences — that may occur during the sessions, attributable to anyone, including ASD THEITALIANSUPERBATTLE and AMUB SPA, during **the days of 26 and 27 September 2026**.
3. To assume all exclusive responsibility for accidents and consequent damages arising for myself and my passengers.
4. To know the general regulations for the use of the track during the free practice sessions.
5. To have verified the perfect functioning of my vehicle before entering the track and to have carried out thorough maintenance.
6. To be aware that the damage and road liability insurance for the vehicle normally does not provide coverage on the circuit unless with a specific extension or ad hoc contract.
7. To be in perfect physical and mental health.
8. To authorise the use of images and videos collected during the event in trade press and social media.
9. To waive any claim against **ASD THEITALIANSUPERBATTLE, PRESIDENT CAVALLETTI ALESSIO and AMUB SPA**, owner and manager of the Circuit, for compensation for damages connected to the entry, stay and/or use of the facility.
10. That compensation for any damage caused directly or indirectly to the structures of the racetrack and to members of the organisation will be at my sole and exclusive expense, relieving ASD THEITALIANSUPERBATTLE, PRESIDENT CAVALLETTI ALESSIO and AMUB SPA from any claim for compensation brought by third parties.
11. To undertake to carry out an initial reconnaissance lap of the facility to verify its conditions and to immediately communicate any anomalies to the staff or track marshals. In the absence of communications after the reconnaissance lap, the state of the facility will be considered tacitly approved. I also declare that I have examined the equipment and services of the racetrack and

relieve the owner, manager and THE ITALIANSUPERBATTLE, PRESIDENT CAVALLETTI ALESSIO from any consequences arising from accidents depending on the state of the facility.

12. The recordings of the security cameras may be retained and used in the event of improper conduct, accidents or damage to other participants and racetrack structures.

13. To undertake, assuming all civil and criminal liability towards third parties, not to allow any unauthorised person to circulate inside the facility with the aforementioned vehicle.

14. To be aware that car parks outside and inside the circuit structure (including garages) are unattended, relieving ASD THEITALIANSUPERBATTLE, PRESIDENT CAVALLETTI ALESSIO and AMUB SPA from any claim following theft and/or damage of any kind.

15. To be responsible for the transponder assigned for timing purposes. In the event of damage (even partial) or loss, the transponder must be purchased in its current condition (€150 + VAT) from the timing company (Perugia Timing).

16. To be aware that personal data will be processed in accordance with Art. 13 GDPR for newsletter purposes.
